

- Click the "Save Search" button on the left side of the screen.
- Give your custom hotsheet a name that you will recognize later if you need to modify it.
- At the bottom of the window, check the "email me" box.
- Click "OK"

## SentriSmart<sup>TM</sup> App - (Continued from page 7)

Play. This nifty new service is brought to you by your association's board of directors at no additional charge to you!

SentriSmart<sup>TM</sup> is a mobile application, allowing access to a lockbox key compartment with the use of a mobile access code instead of a SentriCard®. It also provides immediate showing notifications as soon as the showing agent generates a code. SentriSmart<sup>TM</sup> will still work if your card is expired. As long as your cell phone has a signal, the SentriSmart<sup>TM</sup> app can generate a mobile access code so that you can access the key compartment of a SentriLock lockbox.

When using SentriSmart<sup>TM</sup>, please be aware that a showing notification is sent to the listing agent as soon as you generate a code. If you generate a code just to see how it works, please use one of your own lockboxes to avoid falsely generating a showing notice.

Once you have downloaded the app enter your SentriLock ID (4 digit member ID-CAAR) and your SentriLock password (this is the password you use when updating your card in the reader).


